#### **Health Highlights for Bollinger County**

#### **County Health Rankings**

Bollinger County is ranked 68 out pregnancy rate (41 per 1,000 of 115 counties on health outcomes. Bollinger County residents have an overall better quality of life compared to other counties in the state (ranked 54 out of 115). Bollinger County has average rates for poor mental and physical health days, as well as low birthweight. Bollinger County was ranked 86 out of 115 counties for health behaviors. #### Lead Assessment/Testing

Missouri's children are at risk for lead poisoning, a preventable health problem which affects the brain. At the Bollinger County Health Center, children are tested with a simple fingerstick, so that if there is lead in a child's environment, steps can be taken to


avoid getting toxic levels in their bodies. When high levels are detected, the child is followed by a nurse case manager until the lead level is in normal range. In 2018. the Health Center tested 161 children for lead exposure. Pregnant women are also at risk for lead poisoning, which can be


#### Vital Records

The Bollinger County Health Center provides certified copies of Birth and Death Certificates. This service is available through the Missouri

Department of Health, Bureau of Vital Records. Birth certificates are \$15 per copy for births after 1920. Death certificates, for deaths occurring after 1980, are

\$13.00 per copy. The Health Center fulfilled 1,179 certified copy requests in 2018.

#### **Health Education Services**

PHYSICAL ACTIVITY: In 2018, 6 people were enrolled in the **Arthritis Foundation Exercise Classes.** The Arthritis Classes are ongoing and are offered on Mondays-Wednesdays-Fridays at the Senior Nutrition Center.



Youth Tobacco Prevention: Students from Meadow Heights and Woodland School Districts attended both local and regional trainings hosted by the Tobacco Free Missouri Youth Advisory Board. Their mission is to promote healthy lifestyles by advocating for a tobacco free Missouri, educating youth about the risks of tobacco use, and empowering future generations to be tobacco free. Although the Youth Tobacco Prevention grant is no longer available, the Health Center still provided technical assistance to the schools. The Health Center participated in Meadow Heights' annual antitobacco health fair by providing education and activities about the dangers of tobacco. **NUTRITION/ HEALTH EDUCA-**

**TION:** Nutrition and health education services are provided as requested. Materials are provided for the annual Bol-

linger County Resource Fair, Bollinger County Fair, and other events as requested. Representation is provided for school health boards and various area coalitions. Regular presentations are made for Community Counseling Center's Psycho-Social-Rehab. One presentation was made for Leopold's 8<sup>th</sup> grade health class.



**CDSMP:** Through a partnership with Mississippi County Health Department and the Regional Arthritis Center, the Health Center has five staff members who are certified to teach **Chronic Disease Self-Management Pro**gram (CDSMP). This is a six week workshop that helps participants learn to manage their chronic disease through diet, exercise, and working with their health care providers. In 2018, 9 participants completed the CDSMP course.

**DSMP:** Through the same partnership with Mississippi County Health Department and the Regional Arthritis Center, the Health Center has five staff members who are certified to teach Diabetes Self-Management Program (DSMP). This is a six week workshop that helps participants more effectively manage their diabetes through meal planning, exercise, and monitoring their blood sugar. In 2018, 14 participants completed the DSMP course.

SHSH: This grant was an extension of the HEAL grant. This grant provides funding and technical support for local stores to stock healthier food options. Stock Healthy, Shop Healthy helps communities gain access to healthier and affordable foods through local corner stores and gas stations. These stores are asked to provide healthier choices for their customers with the stock that is already there. As of 2018, Bollinger County has three Stock Healthy, Shop Healthy stores.

The Health Center and Home State Health sponsored a gardening class in collaboration with the University of Missouri Extension on how to grow your own herbs to 33 community members.



#### **Vaccines for Children Program**

The Vaccines for Children Program (VFC) is funded by CDC and provides free vaccines to children who qualify. Children must be under the age of 19 years and meet one of the following requirements:

#### Vaccine Preventable Disease

Immunizations are given at the Health Center on Wednesdays from 8 am to 3:30 pm and other days by appointment. In 2018, a total of 2,192 immunizations were administered, including 146 vaccines at no cost to uninsured adults.

#### Immunization Awareness and Access Initiative

In December of 2014, the Health Center was awarded the Immunization Awareness and Access Initiative from the Missouri Foundation for Health. The four-year grant covered immunizations for children and adults who did not have a payment source, provided education to the public on immunizations, and sponsored a yearly regional

nurse's workshop including topics about immunizations. The grant ended November 30, 2018. A combination of community based interventions was used to increase the demand for vaccinations in Bollinger County. Public health nurses in the region were offered educational opportunities to expand knowledge of immunization protocols and improve the efficacy

of immunization programs. The final training, April 5, 2018, was attended by 80 public health professionals\*\*

#### Women, Infants, and Children (WIC)

WIC is a supplemental nutrition education program that helps mothers and young children eat well and stay healthy. Women, Infants and Children who meet income guidelines may go to any WIC provider in the State of Missouri to apply for WIC benefits. Income guidelines are established by the Unites States De-


#### **Breastfeeding Peer Counselor Program**

The Breastfeeding Peer Counselor Program provides breastfeeding education and support to WIC participants. The Breastfeeding Peer Counselor (BFPC) teaches breastfeeding classes monthly, as well as hosts a quarterly support group. The BFPC also provides one-on-one counseling to moms. The Breastfeeding Peer Counselor Program loans both manual and electric breast pumps. The Breastfeeding Peer Counselor made 699 contacts to prenaare in the Marble Hill Office, and a satellite clinic is held in Patton one day per month.

#### Food Resource Expansion to Support Health (FRESH)

In cooperation with the Southeast MO Food Bank and Marble Hill Food Pantry, Food **Resource Expansion to Sup**port Health (FRESH) is a program that aims to help lowincome seniors in the community. The goal is to improve health by improving nutrition,

#### **Communicable Disease**

#### Surveillance

The Health Center receives weekly reports from daycares, schools and a long-term care facility on the number of illnesses/diseases seen in attendees, residents or clients. The communicable disease nurse reviews this information to monitor the illnesses reported and identifies any trends that affect the public health of the community. Influenza cases confirmed by laboratory testing are also reported to the health center for residents in Bollinger County.

of residents in Bollinger County. Hepatitis C reports on residents with positive Hepatitis C testing results are received. There is no vaccine for this disease, so prevention is best. The Health Center does Hepatitis C screenings through the Hepatitis C Alliance. The communicable disease nurse also receives reports on residents that are experiencing tickborne illness according to laboratory results. Ehrlichiosis, Rocky Mountain Spotted Fever, Lyme and Tularemia are examples of tickborne diseases that are investigated in Bollinger County residents. See the chart below for the number of Bollinger County residents reported to this agency with tickborne illness in the preceding four years. Sexually Transmitted Disease Public Health Nurses can provide screenings for chlamydia,

on site for chlamydia and gonorrhea. Follow-up of HIV and Syphilis are handled by Missouri Department of Health staff. Chlamydia is the most reported sexually transmitted disease.

Rabies

While no animal rabies was reported this year in Bollinger County, rabies in the animal population is an ongoing issue in Missouri. Rabies is always a possibility in wildlife. Rabies in humans is almost always fatal. However, there is Rabies Post Exposure Prophylaxis treatment for individuals whom may have had potential exposure to a rabid animal. Pet vaccination against rabies by a licensed veterinarian, is the best prevention of potential human exposure to

#### **Tuberculosis**

The Health Center also does investigations and follow-up of all positive tuberculin skin test done at the Health Center or those reported by another agency. Public Health Nurses provide case management services for Latent TB Infection (not contagious) and TB Disease (contagious). TB screening test are offered on Wednesday and other days by appointment. This test is placed one day and read 48-72 hours later.

#### **Environmental Public Health**

The Environmental Public Health Specialist inspects school cafeterias, restaurants, taverns, retail grocery, food complaints, daycares, lodging establishments, and sewage systems.

Approximately 86 food establishments were inspected based on their risk assessment to prevent food-related illnesses. There are 12 daycares inspected annually for safety and sanitary issues. Hotels/ motels, if licensed, are inspected annually to ensure public

#### Medical Reserve Corps (MRC)

The mission of the MRC is to engage volunteers to strengthen public health, emergency response and community resiliency. Bollinger County has had a Medical Reserve Corps since 2/15/2007. Its primary reason for establishment was to assist the Local Public Health Agency with the implementation of mass treatment for the National Strategic Stockpile and to administer Influenza vaccinations to resiand findings, some undergo multiple rounds of re-inspections until they conform to safety guidelines.
